

Find out more ring Angela Orford on 0121 561 6210 (Footman James) In the 1990s The Miniature Railway Liaison Group (MRLG) was set up in coniunction with, and hosted by, the Health and Safety Executive (HSE) and consisted of representatives from all model engineering associations/federations, certain model engineering societies, the model engineering press, the model engineering trade, commercial miniature railway operators, insurance representatives and the Office of the Rail Regulator. Amongst other work undertaken by the Group HSG 216 was drafted and published and the agreement reached that the separate boiler test codes of the 71/4" Gauge Society, the Northern Association of Model Engineers and the Southern Federation of Model Engineering Societies be merged in to one universal test code. A subcommittee, the Boiler Test Group (BTG), was set up to undertake this task.

The Health and Safety Executive considered that the life

of the Miniature Railway Liaison Group had reached an end and the Boiler Test Group was left to continue its work on the boiler test code. The various Organisations involved with Model Engineering activities have decided that the current Boiler Test Group should, in future, be regarded as a Group set up by the Organisations and that it should have wider terms of reference so that it can act as a route for any further consultation required on any matters concerned with the hobby. The group is to be known as the Model **Engineering Liaison Group** (MELG).

In the interests of efficient management the core membership will be kept as small as possible. However, in the event that there is a specific item on the Agenda that requires specialist knowledge, any of the Organisations represented can request additional representative attendance for that meeting, or part of that meeting when such an item is to be discussed.

1. The Group shall be known as the Model Engineering Liaison Group (MELG).

2. The membership of the Group will normally consist of one formally appointed representative from each of the following organisations:

The 7¹/₄ inch Gauge Society. The Midland Federation of Model Engineers. The Southern Federation of Model Engineering Societies. The Northern Association of Model Engineers (NAME).

The Insurance Brokers of the relevant organisations are invited: Footman James Walker Midgley Royal Sun Alliance

BOILER TEST CODE REVISION

The Model Engineering Liaison Group (MELG) is to undertake a revision of the model engineers' boiler test code (often known as The Blue Book). The MELG comprises representatives from the 7¼ inch Gauge Society, the Midland Federation of Model Engineers, the Northern Association of Model Engineers and the Southern Federation of Model Engineering Societies, plus Walker Midgley, Footman James Insurance Brokers

along with the principal insurers Royal & Sun Alliance (RSA). The intention is not to change the boiler test procedure but to make the code more user friendly and any amendments that may be beneficial in the light of several years operational experience.

A major part of the revision is the consideration of comments and suggestions received from clubs, societies and individuals. If you have any comments which you would like to be considered they should be sent to the Southern Federation representative for the Group Wally Pearson. The contact details will be found at the end of this Newsletter.

The closing date for comments to be received is 31st December 2011.

BOILER TEST GROUP MEETING (MELG)

On the 14th September 2011 A full meeting was attended by seven members of the committee.

 2. 3. Covered apologies for absent' notes from the last meeting and matters arising.
4. Terms of reference. Terms of reference were agreed.

5. HSG 216

The latest information received from within the organisation was that Entertainment Sheet 12 was being withdrawn by the HSE. HSG 216 was once again with the ORR. There was no intention to re-write or up-date the document in the immediate future. Only copies of the original document were currently available.

All organisations and their member societies are reminded of their obligations under RID-DOR. There was a requirement to report incidents, in particular if someone was injured.

Boiler Design Code; 7. Boiler construction: Beginners guide to boiler building.

The meeting discussed the objective and merits of each of the three topics. Whilst the Southern Federation. View was that the number of people requiring a design code was small. However, there was a need for documentation that would provide consistent and hobby helpful information.

The meeting briefly discussed the possibility of 'adopting' the Australian code in place of 'adapting' it or having to re-write it. This leads to the requirement for someone to contact the appropriate authorities for further discussions.

The Group therefore issues a request that anyone within the hobby who is interested in the creation of documents regarding the above items should contact the Chairman, Mr. Wood, before the next meeting.

9. Welded Copper Boilers. Welded copper boilers mat be acceptable provided that:

- Certified material is used with supporting paperwork.
- B) The welding carried out by a competent and certified welders qualified for welding the material.

These requirements are mentioned in the Blue Book. The meeting noted that retrospective testing and CE marking of copper boilers has not been successfully achieved.

10. Stainless steel boilers. At present the Blue Book states that stainless steel boilers shall not be tested. However, the RSA will accept commercially **made and tested** stainless steel boilers provided they meet approved design standards and the boiler has a commercial test certificate.

The meeting noted that the AMBSC Code, Part 4—Issue 1 2010 was now available. This could be used as a basis for a duplex steel boiler and the RSA would welcome the opportunity to assess and possibly test a boiler constructed from this material.

11. Boiler seminars. **12.** Routine boiler maintenance seminars. There is the possibility of a further seminar being arranged by NAME in the New Year. The location will be advised to the organisations.

The topic of boiler maintenance could be included in the matters covered if the organisers agreed.

13. Boiler tests and the need for a witness. Further discussions will take place and it will be dealt with later.

14. Written scheme of examination (WSOE). A draft of a proposed WSOE for a copper boiler had been circulated by Mr. Pearson. He outlined the reasoning behind the document. The point being made was that the technical information existed and that the WSOE points to the place where information may be found.

Mr. Garnett (RSA) added that the Blue Book content was OK but updating could include details that 'tied' the boiler being inspected to the WSO.

Following extensive discussion regarding the requirements of a WSOE and the details that could be included, or were necessary for the hobby paperwork, Mr. Pearson offered to carry out further work on the document he had drafted.

15. Boiler test code. Following the previous discussion, all agreed that the Blue Book had reached the time when it should be 'revised'.

Mr. Pearson offered to revise the document and it would be useful to incorporate the WSOE requirements and references into any future edition.

There were topics that had been notified to the organisation for possible incorporation into future revisions and these would be considered. All organisations were asked to send any amendments in writing to Mr. Pearson through their Boiler Sub Group representative for consideration. This included issues raise by the Southern Federation prior to the publication of the current 'Blue Book'. The Chairman agreed to draft a notice for the Model Engineering press. All comments to be received by 31st December 2011.

An amendment regarding boiler storage was passed over for possible incorporation.

Clarification regarding the size of boilers covered under the hobby scheme was to be incorporated into the revision.

New Model Engineer Exhibition for Manchester

Meridienne Exhibitions have announced that they will be organising another Model Engineering Exhibition at Event City, part of Trafford Centre in Manchester. The dates are the 2nd, 3rd, and 4th of March 2012. **16. Model gas tanks.** Based on the NAME document the Southern Federation had drafted a revised boiler test supplement covering the safety of LPG tanks. The reasoning behind the rewording was explained, as was the revised test procedure. Mr. Garnett raised some questions regarding the test procedure outlined in the Southern Federation document.

17. Gas pressure systems. There is an increase in interest and construction of gas fired locomotives and other steam raising plant. Following discussion the meeting agreed that the uneducated use of 'gas' systems was not helpful and guidance would be useful.

A recent publication by the model engineering press relation to gas firing a 71/4 gauge Romulus raises concerns about the situation. The suggestion to connect the system with some 'cheap rubber hose' which in turn is fitted as a push fit on a copper pipe stub very close to open flame is not what is expected as safe practice. Gas hose, partially for propane, are to a specific British Standard. The hobby needs some guidance to be circulated to prospective builders before there is an incident. The Chairman agreed to contact the LP Gas Association, Ringwood, on behalf of the group. The meeting also asked that the model gas tank question be raised. A report back would be made.

18. Gas turbines. The number of gas turbines and similar equipment in use was small. The meeting agreed that where such novel equipment was to be used the owner and the owner of the premises on which the equipment operates have a duty of care to others. This may be achieved by carrying out a risk assessment before the items are put into use and ensuring any safety related items that may be necessary are also to hand, for example fire extinguishers etc. It may be appropriate to make contact with or make reference to the Gas Turbine Builders Association who may well have documentation and procedures already in place.

19. Reactors. The group have no experience in this field of the hobby. Should the device be radioactive and a possible risk then the appropriate authorities should be contacted regarding requirements for use

and possible transport.

20. Club boilers. The questions are:

- Does the CE compliance exemption apply to boilers built by a club for their own use? The response was 'YES' boilers built by a club for their own use do not need CE marking.
- 2. May a club test a boiler which is owned by them?. The response was 'Yes'.
- 3. May a club test a boiler which was built by them? The response was 'Yes' provided the actual 'builder does not test the boiler.

21. Unmarked foreign boilers. Boilers that were purchased commercially after May 2002 should be CE marked. If a boiler manufactured after that date is presented for test under the Blue Book scheme it may not be tested.

The meeting was advised that boilers manufactured outside the EU are also subject to the regulation.

22. Materials and specification. It is the responsibility of the purchaser of any material used in a boiler to ensure that the material is suitable for the purpose. Before commencing construction potential builders should consult their boiler inspectors who may wish to satisfy themselves that the correct material is being used.

Where there is any doubt the purchaser must request and obtain appropriate certification. If certification is not available then the material should no be used.

23. Insurance. Traction engines or any other steam operated vehicle should have a valid boiler and steam test certificate before being operated, especially in public areas. There are no exceptions and third party insurance does not cover boiler operation.

24. A.O.B. Mr. Armstrong raised a question regarding boiler inspection certificates. A boiler certificate must be able to be linked to an identifiable boiler. If the boiler and paperwork do not match, or are unconnected then the paperwork and boiler are not acceptable.

Where there was any doubt as to the construction or suitability of new boilers, issues could be referred to the HSE or Trading Standards.

It has come to our attention that some Clubs/Societies are requesting payment for Boiler Testing. You are reminded that this is not permissible under the terms of our Insurance Policy.
