addition, he is a Club trained signalman and guard for public running days. ## MODEL ENGINEERING LIAISON GROUP REPORT

This is a report on the MELG meeting held at Bedford on the 9th February 2012.

All members attended there were no apologies.

### Gas Tanks and LPG Systems

Gas tanks. There has been no progress on this topic. A review by HSE has also not taken place.

LPG systems. No further information is available from UKLPG at present.

Wally Pearson has a substantial amount of information on this topic, including a draft document produced by AALS. Due to the pressure of other items both topics will be left in abeyance and returned to the agenda at a later date.

#### **Boiler Test Code**

Tony Wood was thanked for his preparation of the documentation. This included all comments submitted from 2008 to 31st December 2011. A further document was also produced that would assist with replies to all those who had contributed.

Wally Pearson was also thanked for his work in rewriting the current Blue Book into a form that can be used as a basis for review, BTC 2012 V3

The meeting agreed to proceed with a complete review of the document tabled by Wally Pearson. Following agreement on the wording of this review all topics submitted would be appraised and their relevance determined.

When a fully revised document is in a suitable form and agreed by representatives, the MELG would approach the RSA for a further review of the contents.

The meeting agreed that any boiler test document issued would not be retrospective.

The review of the document BTC 2012 V3 then commenced using a text on screen presentation. It emerged that section 7 of the document had been further amended and the latest version was then considered.

The meeting completed an initial review of BTC 2012 V3, but due to time constraints it was not possible to review the Appendices. It was therefore agreed that the document amended so far be designated BTC 2012 V3a. This would be used as the minutes of item 6 on the Agenda and included notes where further wording, additions and text changes should be incorporated.

It was agreed to hold another meeting.

### Meeting continued on the 8th March 2012

During an extended meeting the whole of the document was reviewed and amended as the meeting progressed. It was then agreed that the BTC2012 V4 was then in a suitable form for inclusion of the comments received by the hobby. The statement, comments and questions which had been submitted by individuals were incorporated into a document entitled 'Comments by subject'. Each of the comments received was considered. Where appropriate the text of BTC2012 V4 was amended. Some topics required further information to be obtained and these items were noted in the comments document.

By the end of the day 190 comments had been considered another meeting was required.

A revision of the boiler paperwork and documentation was felt necessary although some of the certificates existed in draft form, these will be collated and presented.

The question of printing costs and the numbers required was briefly touched on and each organisation would assess their requirements.

The question of Small Boilers, Flash Steam, Steam Cars and passenger carrying boats were to be refered to Bob Garnett of RSA as to weather they should be included in the model scheme.

### Meeting continued on 3rd April 2012

Following the March meeting a draft V5 of the BTC 2012 was circulated. This version was scrutinised and amendments made where necessary. The question of small boilers for steam boats was discussed and it was agreed to leave this item and check with RSA as to whether they should be included in the revised Test Code.

It was decided to include the definitions of Shell Test, Initial Test and Repeat Test. These definitions could be added to Section 3.

Further discussion on topics and the inclusion of amendments enabled draft version 6 of the BTC 2012 to be agreed.

The remaining topics raised by the hobby were considered. Responses were made to those topics and this concluded the consideration of the 250 items that had been presented to the MELG December 31st 2011.

Updated paperwork, an examination certificate and a written scheme of examination, for use with the revised BTC 2012 was presented and discussed. Amendments were made as appropriate to the paperwork and a draft Version 6. Should the Written Scheme of Examination be implemented it was demonstrated that the complete test code could be produced in A4 format. This document would be part of each boiler's record should the scheme be implemented.

It was agreed to look at the costing's involved in the production of Small Boiler Certificates with a capacity below 3 bar litres.

It was suggested that a list of scenarios or frequently asked questions could be incorporated into the publication of a revised test code. Members of the MELG were asked to forward examples to the Chairman, preferably with explanatory notes and reference to the relevant section of the test code.

Next meeting would be with the RSA at their offices.

## SOUTHERN FEDERATION INSURANCE DIRECTORS & OFFICERS LIABILITY INSURANCE

### What is Directors and Officers Liability Insurance

Directors and Officers Liability Insurance cover protects companies' directors, officers and senior managers against claims arising from their decisions and actions taken whilst managing their business.

# What are a Directors Responsibilities?

The duties of a Director have been established through statutes, regulations and case law and can be down into the following areas:

### Duty of Care and Skill

This is a common law duty that requires Directors to act with 'the care an ordinary man would take in the same circumstance on his own behalf' and with the skill expected from someone with his 'particular knowledge and experience'. Where duties are delegated the Director is responsible for ensuring that the person to whom the duties are delegated is sufficiently experienced, reliable and

### honest.

### Fiduciary Duty

Directors must act honestly, in good faith and in the best interest of the company and must ensure that he does not have any conflict of interest.

### Statutory Duty

There are many statutes that effect the conduct of Directors and Officers including the Companies Act 1985, Insolvency Act 1986, Financial Services Act 1986, Environmental Act 1990, Health and Safety at Work Act 11974, to name but a few.

### • How can Claims Arise

If a Director is perceived to have failed in any of his duties then a claim could come from any one of a number of third parties including:

- Shareholders
- Creditors
- Government and Regulatory bodies

### Employees

- Auditors
- Liquidators
- Customers
- Suppliers

### Why Buy Directors and Officers Insurance?

In a claim situation the Director's personal assets are at risk. Directors cannot rely on the company indemnifying them. Often such an indemnity from the company will be in contravention of the Companies Act. Regardless of the stipulations of the Companies Act in the event of insolvency there will be no prospect of the company indemnifying the Directors and officers.

The Directors and Officers Liability Insurance will pay on behalf of the Director his legal costs and expenses and any civil damages awarded against him. For more information please contact Angela Orford at Footman James.

## RAILWAY ACCIDENTS AT A CLUB OR Society

In the event of an accident it is important that you carry out the correct procedures; this will prevent difficulties later on if the issue is taken up by solicitors or the Health and Safety Executive (HSE). Accidents that involve personal injury must be reported and the following is a guide.

### **Insurance Company**

 Accidents must be reported to Footman James or your insurance broker, within seven days.

- 2. A written report is required detailing the accident and its cause if known.
- 3. Name and address of the injured person.
- 4. Name and address of Club or Society members directly involved with the accident and any witnesses. A written and signed record shall be made of any statements made by these personnel.
- 5. DO NOT reply to any letters or E-mails concerning the accident; These shall be passed on directly, without

comment, to Footman James or your insurance broker.

- DO NOT make any comments or admissions to the injured person, to bystanders, members of the public regarding the accident.
- DO NOT discuss on the telephone any details of the accident. Give them the telephone number of your insurance broker.

### Health and Safety

 All accidents which involve personnel injury are reportable under RIDDOR shall be fully documented. In addition to the accident report taken from the recommended Accident Book B1 510 (or similar) and the appropriate RIDDOR report form (F2508) further basic and supporting documentation, as described in the Southern Federation Guidance Sheet No. 1, should be available.

If you are visited by a member of the Health and Safety Executive he will expect to see formal records of all these actions.

You should also have to hand as your working document "Passengercarrying Miniature Railways, Guidance on Safe Practice" (HSG 216) If over the years you have lost your copy of the document, a replacement can be obtained from our sales counter at Exhibitions and Rallies priced £3.00 or by post from Brian Thompson at £4.50 per copy (see back page for address).

### Calling the ambulance

In the event that the emergency services being called to the site it is important that it is made absolutely clear that the site is a **Miniature Railway** so as not to set off a major disaster alert.
