SOUTHERN FEDERATION SPRING RALLY 19/20TH MAY - GUILDFORD M.E.S.

Guildford Model Engineering Society (GMES) will be hosting the Spring Rally on Saturday 19th May and an Open Day with public running on Sunday 20th May 2012 at the Guildford Model Engineering Society ground at Stoke Park, Guildford, GU1 1TU

The ground covers some 2 acres of landscaped ground with many mature trees with a 990 foot Ground Level $7\frac{1}{4}$ track with two laps making a run and a minimum bend radius of 68 feet and a maximum incline of 1:44 up. There is a 1405 foot raised $3\frac{1}{2}$ and 5 inch tracks. There is a carriage shed, an engine shed, which is serviced by 14 steaming bays with compressed air and electric power for blowers and five service ramps to unload vehicles and a ground level turntable. In addition there is a large 16mm garden railway and a clubhouse with kitchen, shower, toilets and a library. A new large workshop complements the facilities.

For the Southern Federation Spring Rally there is plenty of open area so Model Road Vehicles are also welcome and as usual Boiler Certificates and Steam Test Certificates are required. Road vehicles will require RTA insurance.

On-site caravanning space is available, but pre-booking essential. Refreshments will be available within the Clubhouse.

HOW TO FIND US

By Car

Visitors travelling on the A3 from the south west should leave the A3 at exit for Bagshot (A322). At the roundabout under the A3, take the second exit, A25 Middleton Road. Continue straight on at four traffic light controlled junctions along Ladymead and Parkway. At the first roundabout take the third exit into London Road. SOUTHERN FEDERATION INSURANCE SCHEME IMPORTANT CHANGES

We are pleased to announce a number of changes and additional information regarding the Southern Federation Insurance Scheme.

Temporary Workers

We wish to advise you that temporary workers and volunteers are covered by your insurance policy as long as they are signed in as temporary club members when they are helping at the club premises, the range of work as helpers can be assisting with anything to do with the running of the club or for maintenance work. The cover in place would be exactly the same as it would be for any paid up member of the club as long as you have made the helpers or volunteers temporary members and keep records of their names and dates.

Road Vehicle Insurance

We have become aware of a recent incident concerning a (Steam) Road Vehicle and the Motor Insurance Database (MID). The vehicle was stopped by the Police who checked if they had insurance.

As a result of this RSA have now reissued all RTA certificates for 2011 to include a unique policy number for the Southern Federation Traction Engine scheme and these registration numbers have been loaded on to the MID to avoid members getting letters from the DVLA.

In 2012 all vehicles with RTA insurance and road registered will be included on the MID. This allows the DVLA/MID the power to identify vehicles that are taxed but uninsured. If a member calls because their vehicle does not appear on the MID Footman James will check and identify the reason if necessary up-date their details with the DLA/MID.

Any club member receiving letters should contact Footman James urgently supplying copies of the DVLA letter in order that appropriate letter of indemnity may be issued. Members are requested that in the unlikely event of a member being fined RSA would look to reimburse provided that members have provided copies of DVLA letters to Footman James to submit to RSA

Members Public Liability Extension Cover

We are very pleased to announce that from the renewal 1st April 2012 Member Extension Cover will now be provided within the club/society liability cover of the policy. The club liability cover will now extend to include cover for members attending club/society related shows and in addition any individual event attended by the club member. This will include garden fetes/functions etc. which are Model Engineering related. The limit of cover is

the same as the club/society cover.

As a result of this Form 2 will be discontinued as members will no longer have to arrange separate application for this cover.

Clubs who arrange liability cover will then be responsible for issuing their members with a copy of the liability certificate should any member need a copy to attend any event.

Members Insurance

Members who take out insurance for their models, engineering equipment, buildings and RTA insurance for road vehicles will be sent application forms prior to renewal date by Footman James. You will not have to contact your club insurance co-ordinator to get the forms.

Insurance payment by clubs/societies

For 2012, and this only applies to clubs/societies, NOT MEMBERS, will be able to pay for their insurance by internet banking (BACS).

If you wish to pay by this method you will need to ring Angela Orford at Footman James (0121 561 6210) and obtain the banking details and your reference number.

Policy Document

With all the changes that have taken place Footman James and RSA will be issuing a new Policy Document for 2012. This

document will be sent to you when you renew your insurance.

COMMITTEE MEETING MINUTES

22ND NOVEMBER 2011

Attendees

Apologies for Absence

Roger Curtis and Andy Siddall.

Review of the Minutes of Previous Meeting

Accuracy

It was noted that Mr Pearson's Safety Report (Safety Report 270911.doc), issued prior to the September Meeting, should have formed part of the September Minutes.

Other than this, the Minutes were accepted and signed by the Chairman, and are on file.

Minute Secretary's Report

Correspondence

The following communications had been received:

- Change of contact details at Andover, Gravesend, Merton and Mid Wales - passed to the appropriate Committee Members for information / action.
- Various Newsletters (hard copy and electronic). Forwarded to Mr Walker.
- Enquiry from Andover re Witness requirements and alleged Southern Federation Statement – more detail sought, WP informed. Club has subsequently identified source of rumour (internal to club) – matter now closed.
- Copy of letter from a society re MELG (Original sent to WP).
- A question related to the insurance situation of volunteers assisting a society, who are not society members. Passed to Footman James – correspondence circulated to Committee Members for information.
- The latest Issue of Clive Young's Boiler Capacity information sheet - circulated to Committee Members for information.
- Offer of an article on 2011 Southern Federation Autumn Rally for Newsletter. Relevant club advised of Editor situation and publication date uncertainty.
- Notification from NAME that they had heard that some society boiler

testers were testing (non-society member) boilers on a commercial basis. They would be emphasising to their membership that this practice is not permissible under the current insurance schemes, and sought our support. A notice is now on the Southern Federation Website to this effect, and should also appear in the Newsletter.

- An offer from a society to host a Southern Federation Rally – information passed to BT. However, concerns have been raised about the parking and unloading facilities of their site.
- A communication regarding fliers etc for the 2012 Southern Federation Spring Rally - passed to the appropriate Committee Members for information / action.
- An enquiry relating to the testing of Compressor Air Tanks. Mr Pearson reported that he had replied to the enquiry – tanks of <250 bar litres are exempt.
- A request from Footman James for logo artwork (see later).

No other discussions or communications (verbal or written) held or received by other Committee Members were reported.

Treasurer's Report

A (pre-audited) End of Year statement had been distributed by the Treasurer for committee use.

The Accounts are now with the Auditors, and should be signed by the time of the Alexandra Palace Show.

Mr Rogers observed that the surplus was better than expected – however, this was as a result of only two Newsletters being published. Had these been published, then it was likely that there would be a deficit of some £1500.

Insurance

Footman James Report

The Footman James Report had been previously circulated.

Discussion

The Chairman expanded on the Newport Claim(s). The Local Authority had been approached by the club, with a view to the provision of fencing. The Authority had rejected this on grounds of lack of available funding, but had reduced their rent/rates. The Committee made several suggestions, including "smart water", based on their experiences. The Chairman would pass these on to his

contact within the club.

Mr Pearson had received an enquiry relating to Road Registered Steam Vehicles and the Insured Vehicle Data Base which will be published in the Newsletter.

It was noted that the Premiums would increase this year – it will be recalled that there had been no increase last year.

New Applications/Membership Update

Renewals

The Renewal Pack will go out at the beginning of January, as hard copy.

It was agreed that Affiliation Fees should increase by £1 to £25.

New Applications

We had received a communication from a boat club that a group of people had broken away from an existing club, and wished to transfer affiliation to themselves. They stated that the existing club were happy with this arrangement, as they had no interest in steam matters.

Safety

Discussion

Mr. Pearson gave a report (see annex A) which is summarised below:

- Terms of Reference (ToR) for the MELG. Mr Pearson's authority to sign on behalf of Southern Federation was confirmed.
- Boiler Tests and the need for a witness. Southern Federation, in the interests of the hobby, reluctantly agreed to the proposal. However, the ultimate decision would remain with individual clubs. Mr. Pearson was again given authority to pursue changes to the proposed "certificate", and would act as he saw fit. Mr. Pearson assured the committee that he would inform them of progress.
- .Written Scheme of Examination and Boiler Test Code. To date some 80 comment sheets had been received, and more were coming in. These would be categorised before the meeting with RSA. In reply to a question, he indicated as an example that Captive Spindles was a subject that had prompted a number of comments.
- Model Gas Tanks and Gas Pressure Systems. Mr Pearson suggested that the previously published Supplement be revised, and issued as an Annex to the Boiler Test Code.

COMMITTEE MEETING MINUTES CONTINUED

- This approach was endorsed by the Southern Federation Committee
- Guidance Sheets. One Committee Member felt that the Technical Notes would be seen as “yet more rules and regulations from Southern Federation”, and could be counterproductive. The majority of the Committee disagreed, pointing out that the documents were heavily caveated throughout as being meant for information purposes only, and were not mandatory. Any person complaining to Committee members should have this explained to them.
- Safety Management System. Whilst attending the SBA Seminar, Mr Pearson had acquired an example of an SMS document, which the author gave permission, indeed urged, that we propagate. He also suggested that a seminar may be advantageous to our membership. Mr Pearson undertook to circulate the document.
- Road Registered Steam Vehicle and Insured Vehicle Data Base. Mr Pearson reported that WM advise the Motor Insurance Database as a matter of course. FJ do not do so, and would be investigating the situation

.Wrt detail of incidents, Mr Thompson reported that in the recent meeting with Footman James they had commented that in many cases they could not supply information because they had not been supplied with it themselves. The Insurance Scheme belongs to the Southern Federation, and we were entitled to contact claimants direct (subject to appropriate protection of data). This would appear to be a shift in Footman James policy.

The Secretary and Mr Pearson had recently attended a Seminar hosted by Steam Boat Association (SBA) Services. This was felt to be useful, and useful contacts were established with senior members of SBA and SBA Services. It was agreed that our respective organisations were fundamentally different in function and requirements. However, it was agreed that we would maintain a “strategic alliance” (much as we do with NAME) on matters of common interest. (Secretary’s Note: Chronologically out of order, but recorded here for convenience).

IT Initiative

Progress Report

Though understanding the reasons, the Committee were extremely disappointed that Mr Siddall was not able to be present at the meeting, and no report was available.

The Secretary gave his understanding of the current situation (E&OE).

He was concerned that Committee Members seemed confused over terminology, and hence used terms loosely. His (the Secretary’s) simplistic view is that there are three distinct, albeit inter-related elements:

- The Database, containing Southern Federation Administrative records – containing, inter alia, Membership and Contact details. This could be extended to include Archival documents. Access controlled – different rights (read, write, denied) applying to individuals (Committee through Membership), depending on needs.
- The Website. Effectively an Electronic Newsletter, accessible to the public domain. Currently managed by DALOG, but new version can be turned on as soon as agreed by the Committee. The new one would be a more modern, stylish, version in line with that demonstrated by Dr Baker, and which Committee Members have been invited to evaluate. It will be recalled that the Southern Federation original was configured for dial-up, and those limitations should not apply today. Some (public domain) data can be loaded directly from the Database.
- Mailing System. The simplest component – in essence a very large e-mail listing, enabling mass mail-out to clubs “at the push of a button”. Paper address labels (which are strongly discouraged) can be produced from the Database.

In absentia, Mr Siddall was requested to produce a Progress Report and distribute it as a matter of urgency.

Southern Federation Publications

Logos etc

Prompted by Footman James’s request, the desirability of a Central Library of Artwork Masters was identified.

Brochure

Mr Walker had produced a DRAFT Brochure on Southern Federation benefits for comment. Publication is in abeyance, awaiting Footman James determination on Public Liability Insurance. (Secretary’s

Two nominations had been received for The Polly Award. The Chairman would distribute these to Committee Members.

Newsletter/Website

Newsletter

Following Mr Almond’s sudden departure, the Secretary had published an appeal letter for a volunteer to replace him as Newsletter Editor/Website Manager.

Two expressions of interest had been received.

The first had indicated that he wished to operate remotely; this was not acceptable to The Committee, and he had been advised of this.

The second individual, after discussions with Messrs Thompson, Walker and Hurst, had written to the Chairman stating that he wished to withdraw his application for a variety of reasons – the letter had been circulated to The Committee before the Meeting.

The Secretary reported that he had written to all potential Applicants, requesting that they confirm that they had destroyed all documentation sent to them in the process. Post Meeting note – all have confirmed that they had done so.

Mr Walker had produced a DRAFT Newsletter for December, and was to be congratulated on the considerable efforts obviously expended on it. Subject to a number of editorial comments, the overall view was that it was a stylish product. Committee Members were advised that cut-off date for comment was 25th November, as the intent is to go to print w/c 28th

Mr Walker reported that the total cost (publication and postage) was £400.

Mr Walker sought comments from the Committee on:

- Was the proposed approach acceptable – YES.
- Should Club News no longer be published – YES.
- Would the Committee like him to continue as Newsletter Editor – YES.
- How should it be distributed – Hard Copy as at present.

COMMITTEE MEETING MINUTES CONTINUED

Rallies and Exhibitions

The Chairman thanked those who had helped him at Leamington. He had received a letter of thanks from Mr Deith.

Manning arrangements were discussed for Alexandra Palace, 20th/21st/22nd January 2012.

The following events have been identified for 2012:

- Brighton Modelworld 24th/25th/26th February (Finalise stewarding January)
- Annual General Meeting 10th March at Cosford.
- Harrogate Exhibition 11th/12th/13th May. (Finalise stewarding March)
- Southern Federation Spring Rally 19th May, Guildford.
- Guildford Rally 7th/8th July. (Finalise stewarding May)
- Bristol (Thornbury) 17th/18th/19th August
- Southern Federation Autumn Rally 15th September, Chelmsford.
- The Fosse, 17th/18th/19th/20th/21st October.

Mr Deith had approached the Chairman wrt a new event that he intended to stage in Manchester on 2nd/3rd/4th March 2012. It was agreed that we should decline this invitation due to the number of commitments that we had already made for 2012.

Finally, the Chairman stated that The Northampton Society had confirmed their willingness to host the Southern Federation 2013 Autumn Rally.

Annex A - Safety Report.

Boiler Test Group Meeting Bedford 14 September 2011.

The 'notes' of this meeting have been issued and are available for members to view on the Southern Federation web site.

Terms of Reference (ToR) for the MELG.

The Terms of Reference for the Group are as indicated in the 'notes' of the meeting indicate above. The document has not been signed off since it is waiting for final approval from the Southern Federation, 7¼" G Society and the Midland. There have been no amendments submitted by NAME.

Boiler Tests and the need for a witness.

As above, the document has not been signed off or formally approved. It is waiting for final approval from Southern Federation, 7¼"G Society and the Midland. There have been no amendments submitted by NAME but I have recommended that a formal 'certificate' be presented in place of the worded text given in the Bedford notes. On the assumption that the proposal is adopted it will be necessary for the Southern Federation to obtain names of Club and Society members who are boiler inspectors and, more especially, those if any are authorised as single signature.

Written Scheme of Examination and Boiler Test Code.

The Boiler Test Code review is currently being carried out. At the end of October 2011 over 80 A4 pages of submissions have been received by the MELG from members. A substantial number will follow before the closing date of 31 December 2011.

It is intended for members of the MELG to hold a meeting early in 2012 to discuss the submissions received prior to

holding a further meeting with RSA at Manchester. It is hoped that Wally Pearson will complete the changes to the Blue Book, not including the submissions, by the end of November 2011.

Model Gas Tanks and Gas Pressure Systems.

Tony Wood has made contact with the LP Gas Association for further information. Although there has been a response, it indicated that UKLPG could not think of anything that would help us.

Guidance Sheets.

A limited number of Guidance Sheets have been issued and are available on the Southern Federation web site. In view of the fact that there is some degree of concern on the topic, the continuation or removal of the Guidance Sheets is open to discussion.

Safety Management System.

An option has arisen to provide a pro-forma of a flow chart indicating a Safety Management System (SMS). The document has been provided by a member of the BGLR who is quite willing to allow the use, suitably amended, of the document for small gauge railways. This is a very useful document when used in conjunction with HSG 216 and the Guidance Sheets. It should be noted however that certain usage conditions are attached.

Road Registered Steam Vehicle and Insured Vehicle Data Base.

This topic has been raised with Footman James, but to date I have no information of the outcome. However, a reply has been given by Walker Midgley.

SOME INTERESTING FACTS

The Southern Federation is made up of the following clubs and societies:

10 Associations
13 Model Boat Clubs
2 Clock Clubs
1 Radio Control Club
228 Model Engineering clubs

Based on 243 clubs/societies, not including associations, club sizes are as follows:

Under 10 members 28 clubs = 12%

11 to 25 members 54 clubs = 22%
26 to 50 members 53 clubs = 22%
51 to 100 members 71 clubs = 29%
101 to 150 members 24 clubs = 10%
151 plus members 13 clubs = 5%

The membership levels over the past four years have only changed a little:

2008 - 14,895
2009 - 14,664
2010 - 14,698

2011 - 14,895

This data has been taken from the records you send in each year. It looks as if we are losing members each year, but it is relatively small

The average club membership is 60.

FEDERATION FINANCES

The Federation's financial year ends 30th Sept at which point I close the years' accounts, prepare the closing statements and deliver the books to the auditors who then do their work in readiness for the following March when the accounts are presented to the AGM. The quiet time up to New Year is an opportunity to reflect on any emerging trends in the Federation's income and expenditure. So what trends are emerging that need to be considered?

There can be some abrupt changes from year to year. Printing & stationary costs is a good example and will vary according to what items of Federation stock needs to be replenished so it's better to look at the average over a period of years. There can also be incidental expenses that occur quite randomly but overall these tends to smooth out over the years. Regular expenses including the newsletter, the cost of supporting rallies and exhibitions and the general committee expenses don't vary much from one year to the

next but inevitably are increasing in line with general prices.

In view of the general upward trend of our costs the Federation has been careful with its spending but has still needed to increase the affiliation fee because of a couple of changes beyond our control - taxation and the financial crisis. Prior to 2006 there was a zero band for corporation tax but it was abolished giving the Federation a tax bill of around £1,300 pa, equivalent to £5.00 for each society. In addition the financial crisis has caused our interest received to plummet from £500 in 2008 to £2.19 last year! Fortunately the Federation has reserves that has helped it to ride out the storm but we can't ignore the upward trend in the costs we incur serving the hobbyist.

I would like to say something more on one aspect of Federation expenditure, the newsletter. This was developed over the years into the familiar booklet format but the loss of the editor prompted the Federation to think about what needs to

be communicated to affiliated societies and how to do it. Hence the change of format to the newsletter that you are now reading; a format designed to get essential information to you. We are also developing our presence on the internet. I appreciate that some like it others loath it, but the internet is another communication tool just as written letter and the telephone. It's advantages are considerable - it's instant, it doesn't have to be printed, enveloped, labelled and posted so it's a quicker and cheaper way of getting information out to where it is needed. The Federation now does some administration on line with many clubs and societies submit their renewal fees online. It's not necessarily the end of paper but we are increasingly mindful of the cost of standing still. So keep a watch on the website - it's about to change!!

MODEL ENGINEERING LIAISON GROUP THE BOILER TEST CODE

Information was given in the December 2011 issue of the Southern Federation Newsletter related to the MELG and the Boiler Test Code. At the MELG meeting on 14th September 2011 it had been agreed that the 2008 edition of the Boiler Test Code was due for revision. Members were encouraged to send in their comments for inclusion in the review of the document. At the closing date of 31st December 2011 some 134 pages of comments had been received over a period of time from members of the relevant Federations, Associations and Society. Considering the fact that the existing document, commonly known as the Blue Book, consists of only 21 pages it gives some justification to the requirement for a review. You can be assured that every one of the comments will be taken in to consideration by the members of the

MELG. Thanks go to all of you that took the time and trouble to give this subject your consideration and input.

At the MELG meeting held at Bedford on the 9th February 2012 the Terms of Reference document for the formal formation of the MELG was signed by the representatives of the relevant Federations, Associations and Society. Also at this meeting discussions took place on the subjects of Gas Tanks and Gas Pressure Systems. Although important these topics have not been given priority, with the majority of the time being given to the review of the Boiler Test Code. As you can imagine it was not possible to complete the review at the one meeting and consequently a further meeting will be required. The intention is to reconfigure and amend the document as appropriate before it is presented to the Royal & Sun Alliance for

approval. The minutes of the meeting of the MELG will be published once the second meeting has taken place.

Also in the December issue of the Newsletter it was announce that Guidance Sheets have been issued by the Southern Federation. You are advised that a further Guidance Sheet (No6) has been issued entitled Safety Management System (SMS) see page 4. This document is a valuable aid to be used in conjunction with your Club or Society rule book and the booklet *Passenger Carrying Miniature Railways, Guidance on Safe Practice* (HSG 216).
