# *Little Locomotive Efficiency Competition (LittleLEC)* – *An invitation to take part.*

Most of you reading this will be aware of the high-profile annual efficiency locomotive competition – IMLEC, which caters for 3½" and 5" gauge locomotives of sizes typically capable of passenger hauling. Perhaps less well known is LittleLEC which is also an annual efficiency competition for drivers of small locomotives weighing less than 50lb dry, such as Tich, Rob Roy, Juliet, Mona, etc.

Small locos are much more challenging to drive than larger ones, and so LittleLEC was devised by Guildford Model Engineering Society member, Peter Langridge in 2008 to enable owners of small locomotives to take part in an IMLEC style efficiency competition. The event is usually held in June at a different Model Engineering Society's track each year, up, down, and across the country to allow a different set of locomotive owners to take part without having to travel great distances. The competition is open to 2½", 3½" and 5" gauge locomotives depending on whether the host society has a multi-gauge raised track.

In terms of the competition itself, just like IMLEC, the efficiency is calculated from the work done by the loco and the weight of coal consumed. Instead of using a mechanical or electronic dynamometer, LittleLEC efficiency calculations are based on the distance travelled, the weight of the train's rolling stock, and the weight of the drivers and any passengers or any added ballast. A track factor derived for the track's gradient profile and assumed rolling resistance for the rolling stock is used to calculate the work done, and this is compared with the amount of coal used.

LittleLEC is sponsored by Model Engineer magazine which provides small cash prizes. There is also a cup which is held by the current year's winner, and also a locally awarded special prize which is often for the best turned out entry.







# Federation Trophy and

# Polly Model Engineering Prize 2024

This long-standing competition is a joint award for young people developing their model engineering skills and interests. It is not just about well-made models, it is about a Young Engineer demonstrating their interest and enthusiasm in making models, parts of models or associated equipment of all types of engineering (ie railways, cars, boats, planes, stationary engines, tools and equipment etc) AND describing their contribution to the life and activities of their Model Engineering Club. The entry requirements (which comprise the presentation of a portfolio of activities sponsored by a club 'mentor') describe this in some detail and this document alone can be a valuable aid to supporting applications for colleges, universities and jobs as well as providing information to the judges.

The prizes are awarded to those who the judges consider have developed their abilities the best as described in the entry, and these consist of commended awards and one winner. All receive cash prizes, and the winner also receives a glass trophy to keep.

At the time of writing, our judges are contemplating the entries - traditionally the prizes are awarded at the annual FMES AGM event day, and we look forward to meeting our winners on 2<sup>nd</sup> March for this year's event! Those concerned will have already or will be about to receive an invitation to the event to collect an award in person, we do hope that they will be able to attend!

# Young Engineers – follow-up

Following the feature in the last Newsletter which related the experience of Peter Kennion and his son Matthew and the encouragement of young engineers at Hereford, I am grateful to John Roberts who has sent in the following description of their work with young engineers at Pimlico Light Railway in Northamptonshire.

"We are a young club (officially starting in 2006) and have never had more than 30 or so members, but during 2023, 9 of the 30 were in full time education and a further 12 are in full time work which I suppose makes us unusual as we are not a 'top heavy' club.

We have always had a policy of welcoming young people who can officially become members when they are 7 years old but have to join with an adult member of their family. The club is based in a private garden and has few facilities apart from the owner's workshop. We do have a training scheme, the usual Bronze, Silver and Gold awards and then finally when full competence and 16 years of age are reached we have our 'Grease Top' award when they are presented with a proper grease top cap. (Up until now bought from Walker Midgely - are they still available?)

Over the years several of our young members have been awarded 'Polly' or 'NAMES' prizes and have gone on to be very successful in their chosen careers. There have been apprenticeships with JCB, Mercedes F1, in the railway industry and in the civil engineering world. Others became teachers, pilots, joined R.M.E., studied architecture and aeronautical engineering at university.

Yes, all have been encouraged in practical engineering, but without major workshop facilities as they have at Hereford, the success that our young people have had is, we believe chiefly, the ethos of the club that has encouraged them. They are welcomed, supported, trained, listened to and eventually treated as full members of the club despite the lack of years."

John has also told of examples of two previous Junior members who have moved on using the engineering experience gained at Pimlico Light Railway. One is now at university and taking a leading role in a society developing human powered aircraft and another currently working in the motor sport industry is now renovating his own loco at a heritage railway.

# CE marking of boilers: update 2023

Following recent questions, we have complied a brief note on this topic. This is available on our website at <a href="https://fmes.org.uk/pressure-vessels-and-testing/">https://fmes.org.uk/pressure-vessels-and-testing/</a>. It describes some comments about the implications of CE marks, what is required to verify a CE mark on a boiler and the impact of Brexit.

# Website Access and Logins

If you are not able or doubtful about logging on to the website then here are some easy steps to assist you:

- Much of the website is open to the public and so for a lot of information you do not need to log in, just go to <a href="https://fmes.org.uk/">https://fmes.org.uk/</a> and start browsing!
- If you would like to access some of the other functions (such as seeing your club data and some other information) then you will need a log in. This has two parts:
  - A username: This is the code issued to your club as a universal identifier for your club. It comprises letters and numbers (eg ABC123)
  - A password: If you are the club primary contact, then you will be entitled to the password for you to issue to people at your club under your responsibility (because knowing it gives you access to some of your primary contact and some others' personal details).

If you wish to become your club primary contact (with formal club approval) then please contact us on <u>info@fmes.org.uk</u> for us to enable appropriate access.

You type in your username and password by selecting the 'login' option at the top right of the website home page at <u>https://fmes.org.uk/</u> and following the instructions.

- If you have remembered your username but forgotten your password, then you can do 'forgot password' on the log in page. This will cause an email message to be sent to the email address that is recorded in the system as the primary contact. If you do not remember or have this email address, or have forgotten your username contact us at info@fmes.org.uk.
- If you are not a club officer but you would like to see more information, then your club primary contact should be able to give you the '**Clublite'** password

which will restrict you to only information and not the personal data on the database.

• If you want to read more detail on the website and can log in, please do so and find 'Introduction to the website' in the documents library.

FMES is moving more to providing information and help through the website owing to ease of use and the ability to be more efficient, and we recommend that every club joins this way of working by having at least one person to act as 'primary contact' to co-ordinate FMES communications with their club. This person need not be a committee member as long as the committee approves and supports this responsibility.

We appreciate that not every one has grown up using 'windows', 'apps', websites and a host of other technology and some find these things daunting. The best thing to do is to try! We will never ask you to type in security sensitive things and if you can 'break' our website then it is our fault not yours, so don't worry about this either.
